RESOLUTION NO. SP- **9571**, S-2024

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL PERMIT TO LARGE-HUB MIND RECREATION, INC., TO ESTABLISH AND OPERATE AN ELECTRONIC GAMES (E-GAMES) ESTABLISHMENT LOCATED AT NO. 295 P. TUAZON BOULEVARD, BARANGAY SAN ROQUE, DISTRICT III, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, Large-Hub Mind Recreation, Inc., a domestic corporation duly organized and existing under and by virtue of Philippine laws, with business address at No. 295 P. Tuazon Boulevard, Barangay San Roque, District III, Quezon City, is applying for the issuance of a Special Permit to operate an Electronic Games (E-Games) establishment;

WHEREAS, the applicant is applying for a Special Permit for the operation of an E-Games establishment located in a permissible place as per zone classification;

WHEREAS, to enable the applicant to conduct electronic gaming activities in its business operations, there is a need to apply for a Special Permit for the operation of an E-Games establishment pursuant to an existing City ordinance;

WHEREAS, the operation of an E-Games establishment is regulated and licensed by the Philippine Amusement and Gaming Corporation (PAGCOR);

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a Special Permit to business activities of the same nature.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Permit to Large-Hub Mind Recreation, Inc., to establish and operate an Electronic Games (E-Games) establishment located at No. 295 P. Tuazon Boulevard, Barangay San Roque, District III, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an E-Games establishment granted herein shall be subject to the following conditions, to wit:

1. The holding of E-Games shall be in accordance with the rules and regulations promulgated by PAGCOR;
2. The operation of an E-Games establishment shall not include playing of games not related to or other than E-Games;
3. The operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below 21 years of age or students of any school, college or university;
4. Large-Hub Mind Recreation, Inc., shall remit a license fee of 3% of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution, in accordance with Section 25 of Ordinance No. SP-2773, S-2018, as amended; and







5. This Resolution is non-assignable, non-transferrable and site-address specific.

RESOLVED FINALLY, that this issuance of a Special Permit to operate an E-Games establishment shall be valid for a period of 2 years from the approval of this Resolution and may be renewed again by the City Council.
