A RESOLUTION RENEWING THE SPECIAL PERMIT OF AB LEISURE EXPONENT, INC., TO OPERATE A TRADITIONAL AND ELECTRONIC BINGO (E-BINGO) ESTABLISHMENT AT SM CITY NORTH EDSA ANNEX BUILDING, EDSA, BARANGAY BAGONG PAG-ASA, DISTRICT I, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

*WHEREAS, AB Leisure Exponent, Inc., a domestic corporation duly organized and existing under and by virtue of Philippine laws, located at SM City North Edsa Annex Building, Edsa, Barangay Bagong Pag-asa, District I, Quezon City, is applying for the renewal of a Special Permit to operate a Traditional and Electronic Bingo (E-Bingo) establishment;*

*WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of the same business through Resolution No. SP-8655, S-2021;*

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit pursuant to an existing City Ordinance;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a Special Permit to business activities of the same nature.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of AB Leisure Exponent, Inc., to operate a Traditional and Electronic Bingo (E-Bingo) establishment at SM City North Edsa Annex Building, Edsa, Barangay Bagong Pag-asa, District I, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate a Traditional and Electronic Bingo (E-Bingo) establishment granted herein shall be subject to the following conditions, to wit:

1. The holding of a Traditional and E-Bingo shall be in accordance with the rules and regulations promulgated by PAGCOR;
2. The operation of a Traditional and E-Bingo establishment shall not include playing of games not related to or other than Traditional Bingo and E-Bingo;
3. The operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below 21 years of age or students of any school, college or university;
4. AB Leisure Exponent, Inc., shall remit a license fee of 3% of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution, in accordance with Section 25 of Ordinance No. SP-2773, S-2018, as amended; and
5. This Resolution is non-assignable, non-transferrable and site-address specific.

RESOLVED FINALLY, that this renewal of a Special Permit to operate a Traditional and Electronic Bingo (E-Bingo) establishment shall be valid for a period of 2 years from the approval of this Resolution and may be renewed again by the City Council.
