ORDINANCE NO. SP- 2178, S-2012

AN ORDINANCE IMPOSING A ONE PESO (P1.00) INCREASE TO ADMISSION FEES IN ALL CINEMAS IN QUEZON CITY, COVERING THE PERIOD FROM NOVEMBER 1 TO 30, 2012, THE PROCEEDS THEREOF TO BE DONATED TO THE BOY SCOUTS OF THE PHILIPPINES, QUEZON CITY COUNCIL, TO SUPPORT ITS NUMEROUS PROGRAMS AND ACTIVITIES.

WHEREAS, the Boy Scouts of the Philippines, Quezon City Council, a public corporation duly organized and existing pursuant to Commonwealth Act No. 111, as amended by Presidential Decree No. 460 and Republic Act No. 7278, is authorized to "x-x-x-x accept and receive funds, real and personal property by gift, devise, bequest or other means, and to Conduct Fund Raising Activities x-x-x-x";

WHEREAS, for several years now, the said council, which is among the biggest, popular and renowned in the country, has been involved not only in promoting character development, providing adequate citizenship training and leadership among the Filipino youth of the City, but inculcating in them love of country, civic consciousness and responsibility, courage and discipline and similar other virtues and moral values;

WHEREAS, prominent among the activities and services conducted by the Council are those which are geared towards the promotion of moral, spiritual and physical well-being of the youth, the development of sports and livelihood and in assisting the promotion of the environment and waste management program and community development of the City government, among many others;


WHEREAS, this year is very significant to all Boy Scouts particularly those belonging to the BSP Quezon City Council, because on this remaining part of the year, this Council is celebrating its 65th Foundation Anniversary and various youth oriented activities were scheduled as follows: Advanced Training Course for Leaders of Adults on September 17 to 23, 2012 at PSC-APR Training Center, Mt. Makiling, Los Baños, Laguna; NCR KAB Palaro on September 21 to 22, 2012 at the University of Makati - Track and Oval Field, Makati City; 65th Quezon City Council, BSP Jamborette on September 27 to 30, 2012 at the University of the Philippines, Diliman, Quezon City; KID-KAB Sayahan on October 6, 2012 at Angelicum College, Quezon City; Course for Managers of Learning on October 8 to 13, 2012 at PSC-APR Mt. Makiling, Los Baños, Laguna; Scout Rally and Senior Scout Tournament on October 20, 2012 at Quezon Memorial Circle, Quezon City; 9th National Rover Moot on October 22 to 28, 2012 at Puerto Princesa, Palawan; Scouting District Inter-Visitation on October 26 to 28, 2012 at designated schools of the District Scouting Committee; Scout Advancement Camp on November 11 to 13, 2012 at Lagro Centennial Park, Quezon City; 2nd One Regional Jamboree on November 28 to December 2, 2012; Council Christmas Camp on December 26 to 30, 2012 at Baguio City, other than those already conducted from January up to this time. The above activities will benefit some 10,000 scouts and scouters who will attend and participate actively on these scheduled events;

WHEREAS, as a clear manifestation of its support to this Council, the City Government intends to increase the admission fees in all city's cinemas by One Peso (P1.00), thereby, in the process, paving the way in the realization of the mission and vision of the boy scouting movement in Quezon City.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Admission fees in all cinemas/movie houses operating in Quezon City are hereby increased by One Peso (P1.00) from November 1 to 30, 2012.



SECTION 2. *The proceeds derived therefrom shall be donated to the Boy Scouts of the Philippines, Quezon City Council, to help support and finance its various programs and activities.*

SECTION 3. *All concerned movie/cinema owners and operators are hereby authorized to transmit and turn-over to the BSP-Quezon City Council Scout Executive all sums of money collected, who will in turn, account in the acknowledgement of the money received, subject to the usual accounting regulations. The City Treasurer is directed to submit the corresponding report to the City Council in connection therewith.*

SECTION 4. *Let the copy of this Resolution be furnished to the Quezon City Treasurer, the BSP-Quezon City Council Scout Executive and all cinema owners and operators operating or conducting business in Quezon City, for their information and proper guidance.*

SECTION 5. *This Ordinance shall take effect immediately upon its approval.*
