ORDINANCE NO. SP- 2188, S-2012

AN ORDINANCE ALLOWING THE IMPLEMENTATION OF THE TRAFFIC MANAGEMENT SCHEME IN CERTAIN STREETS OF BARANGAY EAST KAMIAS AND PROVIDING PENALTY FOR VIOLATION THEREOF.

WHEREAS, Section 458 (a) (5) (v) and (vi) of Republic Act No. 7160, otherwise known as "The Local Government Code of 1991", provide for the powers, duties, functions of the Sangguniang Panlungsod;

- (v) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same xxx.*

- (b) *Regulate traffic on all streets and bridges, prohibit encroachments or obstacles thereon and when necessary in the interest of public welfare, xxx.*

WHEREAS, the Barangay Council of Barangay East Kamias passed Resolution No. 078-11, Series of 2011, entitled:

Resolution asking the City Council for the Implementation of an appropriate Traffic Scheme, a one-way traffic flow, and a one-lane parking on specific streets of Barangay East Kamias, of this city.

WHEREAS, there is a necessity to implement a Traffic Management Scheme along certain streets of Barangay East Kamias to ensure order and discipline within the area;

WHEREAS, it is incumbent upon the City Government to regulate the traffic situation and road conditions within its jurisdiction.

NOW, THEREFORE,


**BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY
IN REGULAR SESSION ASSEMBLED:**

SECTION 1. TITLE – *This Ordinance shall be known and referred to as the “Traffic Management Scheme of Barangay East Kamias”.*

SECTION 2. STREETS COVERED – *The Traffic Management Scheme shall be enforced on the following streets.*

A. Streets with two-way traffic flow

- 1) *K-1 Street*
- 2) *K-J Street*
- 3) *Kasing-Kasing Street*
- 4) *Anonas Street*
- 5) *K-9th Street*

- 6) K-10th Street
- 7) K-11th Street
- 8) K-J Street

B. Streets with one-way traffic flow

- 1) K-6th Street from K-1 Street to Anonas Street
- 2) K-7th Street from Anonas Street to K-1 Street
- 3) K-8th Street from K-1 Street to Anonas Street

C. Streets with one-side parking

- 1) K-6th Street – Left side parking from K-1 Street towards Anonas Street
- 2) K-7th Street – Left side from Anonas Street towards K-1 Street
- 3) K-8th Street – Left side parking from K-1 Street towards Anonas Street
- 4) K-10th Street – Left side parking from Anonas towards Kamias Extension


D. Streets with no parking on both sides

- 1) K-J Street
- 2) Kasing-Kasing Street

SECTION 3. ENFORCEMENT – This ordinance shall be enforced and implemented by the Department of Public Order and Safety (DPOS) and by the Barangay Public Safety Officers (BPSO) of Barangay East Kamias.

SECTION 4. PENALTY – Any person or persons found violating the provisions of this Ordinance shall be penalized with a fine of not less than one thousand pesos (P1,000.00) but not more than five thousand pesos (P5,000.00).

SECTION 5. REPEALING CLAUSE – All existing ordinance and resolutions, local executive orders, rules and regulations inconsistent with any of the provisions of this ordinance is hereby repealed and/or modified accordingly.
