ORDINANCE NO. SP- 2782, S-2018

AN ORDINANCE INCREASING THE LONGEVITY PAY OF PUBLIC SCHOOL TEACHERS IN QUEZON CITY, FROM ONE HUNDRED PESOS (P100.00) FOR EVERY FIVE YEARS TO FOUR HUNDRED PESOS (P400.00) FOR THE SAME PERIOD, AMENDING ORDINANCE NO. SP-1407, S-2004, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES.

WHEREAS, Section 17 (a and b) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, specially authorizes the local government units to give support to education:

SECTION 17. Basic Services and Facilities.

- (a) Local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities enumerated herein.
- (b) Such basic services and facilities include, but are not limited to, the following:

(4) For a City:

(ii) Support for education, police and fire services and facilities;

WHEREAS, Section 458 (a)(1)(viii) of the Local Government Code of 1991 likewise provides:

SECTION 458, Powers, Duties, Functions and Compensation -

(1) (viii) Determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the city government;

WHEREAS, it is a policy of the Local Government of Quezon City to uplift the living conditions of its officials and employees, particularly public school teachers;

WHEREAS, a financial assistance to public school teachers through an increase in their longevity pay will improve not only their living conditions but also their efficiency and effectiveness as public officials.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. INCREASE IN LONGEVITY PAY - The longevity pay of public school teachers in Quezon City is hereby increased, from One Hundred Pesos (P100.00) for every five (5) years of continuous service to Four Hundred Pesos (P400.00) for the same duration. Henceforth, the amount previously granted shall be added to the earned longevity pay of said public officials on the immediately succeeding pay period of five (5) years.

SECTION 2. PROSPECTIVE APPLICATION – This Ordinance shall apply prospectively to public school teachers who shall have rendered at least five (5) years of continuous service, exclusive of such services rendered outside the territorial jurisdiction of Quezon City, upon its approval. For those, who shall have rendered at least ten years of service, a gap of one (1) year in such service may be allowed, provided, the same arose on account of medical and/or grave personal problems.

SECTION 3. APPROPRIATION – Such amount as may be necessary for the implementation of this Ordinance is hereby appropriated from the General Fund or Special Fund.

SECTION 4. AMENDATORY CLAUSE – Ordinance No. SP-1407, Series of 2004 and such other ordinances and/or resolutions inconsistent with this Ordinance are hereby amended accordingly.

SECTION 5. SEPARABILITY CLAUSE – Should any part or portion of this Ordinance be annulled by a court of competent jurisdiction, what remains hereof shall continue to be in full force and effect.
