ORDINANCE NO. SP. 2786 __, S-2018

AN ORDINANCE ESTABLISHING A HIGH SCHOOL IN BARANGAY GREATER FAIRVIEW, QUEZON CITY BY CONVERTING THE NORTH FAIRVIEW HIGH SCHOOL ANNEX LOCATED IN AUSTIN STREET, BARANGAY GREATER FAIRVIEW, QUEZON CITY INTO A SEPARATE AND INDEPENDENT INTEGRATED HIGH SCHOOL TO BE KNOWN AS WEST FAIRVIEW HIGH SCHOOL.

WHEREAS, Section 391 paragraph 21 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang barangay shall initiate the establishment of a barangay high school, whenever feasible, in accordance with law:

WHEREAS, the existing high school in Barangay Greater Fairview located in Austin Street, Barangay Greater Fairview is a high school annex of North Fairview High School;

WHEREAS, on July 5, 2018, the Sangguniang Barangay of Barangay Greater Fairview adopted Barangay Resolution No. Jul-02-005, S-2018, favorably endorsing to appropriate government agencies the establishment of a separate and independent high school in Barangay Greater Fairview;

WHEREAS, the Parents-Teachers Association (PTA) of North Fairview High School Annex also adopted Resolution No. 1, S-2018, seeking the conversion of the existing North Fairview High School Annex into a separate and independent high school of Barangay Greater Fairview;

WHEREAS, the existing North Fairview High School Annex has the available space necessary for the construction and expansion of the school facilities;

WHEREAS, due to the increasing student population of North Fairview High School Annex, it is but proper that a separate and independent West Fairview High School be established in order to hasten the delivery of educational support and services by the Quezon City Government to the residents of Barangay West Fairview.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. There is hereby established in Barangay Greater Fairview, Quezon City a separate and independent integrated high school to be known as the West Fairview High School.

SECTION 2. The North Fairview High School Annex located at Austin Street, Barangay Greater Fairview, Quezon City is hereby separated from North Fairview High School and converted into an independent integrated high school to be known as the West Fairview High School.

SECTION 3. The West Fairview High School established under this Ordinance shall be an integrated high school from Grade 7 to Grade 12.

SECTION 4. The City Mayor is hereby authorized to utilize, realign and/or transfer available funds from the Special Education Fund or any available funds of the Quezon City Government for the proper implementation of this Ordinance. Subsequent appropriations necessary for the operation of the West Fairview High School shall be included in the annual budget of the City.

SECTION 5. The City Mayor may create a special committee for the proper implementation of this Ordinance. $\gamma \longrightarrow \checkmark$
