ORDINANCE NO. SP- 2833, S-2019

*AN ORDINANCE DECLARING ALL STREETS ONLY WITHIN FIRST GREEN MEADOWS SUBDIVISION, BARANGAY UGONG NORTE, DISTRICT III, QUEZON CITY AS "ALTERNATING ONE-SIDE PARKING ONLY, TWENTY-FOUR (24) HOURS A DAY FROM MONDAY TO SUNDAY".*

*WHEREAS, Section 458 (a)(5)(v) and (vi) of Republic Act No. 7160, otherwise known as "The Local Government Code of 1991", provides for the Powers, Duties, Functions of the Sangguniang Panlungsod:*

*"(v) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same, xxx.*

*"(vi) Regulate traffic on all streets and bridges; prohibit encroachments or obstacles thereon and, when necessary in the interest of public welfare, xxx.";*

WHEREAS, the Sangguniang Barangay of Ugong Norte passed Resolution No. 166, S-2018 entitled: "A Resolution requesting the City Council to enact an ordinance declaring all streets only within first Green Meadows Subdivision, Barangay Ugong Norte, District III, Quezon City as "alternating one-side parking only, 24 hours a day from Monday to Sunday";

WHEREAS, the increase of vehicular traffic and the seemingly stunted and increasing breadth of the barangay thoroughfares, streets, avenues, boulevards and alley are further constricted by the wanton and indiscipline parking and/or stalling of vehicles along these roadways;

WHEREAS, there is a need to prescribe a systemized, organized and fully implementable mechanism of maximizing the limited road space available to ensure the smooth and unhampered flow of traffic;

WHEREAS, despite existing provisions for privately-owned and commercially-operated parking spaces, the monitoring public still resort to parking vehicles wherever space is available regardless of its adverse affects on the flow of moving vehicular traffic.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED.

SECTION 1. TITLE - This Ordinance shall be known as the "Alternating One Side Parking Of First Green Meadows Subdivision, Barangay Ugong Norte, District III."

SECTION 2. COVERAGE - All the streets within First Green Meadows Subdivision, Barangay Ugong Norte, District III, Quezon City.

SECTION 3. ALTERNATING ONE SIDED PARKING SCHEME:

LEFT SIDE: First to fifteen of the month (Plate with Odd Number)

RIGHT SIDE: Right Side Sixteen to Thirty First of the Month  
(Plate with Even Number)

*SECTION 4. REPEALING CLAUSE – All Ordinance, Resolutions, Executive Orders, directives, instructions and implementing rules and regulations inconsistent with the provisions of this Ordinance are hereby repealed accordingly.*


*SECTION 5. SEPARABILITY CLAUSE – If for any reason, any provision of this Ordinance is declared invalid or unconstitutional, provisions not affected thereby shall remain in full force and effect.*

*SECTION 6. EFFECTIVITY – This Ordinance shall take effect upon its approval.*


